TRADEMARK ASSIGNMENT

1.1.1. Assignor hereby grants, assigns and conveys to Assignee all of its right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks.

1.1.2. Assignor hereby represents and warrants that it has not heretofore granted any license, right or privilege with regard to the Trademarks, or in any other way encumbered the same, and that it has the full right to convey, free of licenses and encumbrances, all right, title and interest in and to the Trademarks.

1.1.3. The rights transferred by this Assignment include the right to bring all legal actions related to the Trademarks, including actions for any infringement, whether the infringement occurred before or after this Assignment, and the right to recover damages for such infringement.




