**AMENDMENT TO DECLARATION OF TRUST**

To the Secretary of State of  
Commonwealth of Massachusetts

It is hereby stated that:

1. This document constitutes an Amendment to the Declaration of Trust (hereinafter called the "Declaration") of Eaton Vance Investment Advisors (hereinafter called the "business trust").

2. The Declaration amended by this document was filed with the Secretary of State of the Commonwealth of Massachusetts on August 19, 2016.

3. The amendments to the Declaration effected by this document are as follows:  
The name of the trust is being changed to "Calvert Research and Management";  
Section 1.1 is hereby replaced in its entirety with the following:

Section 1.1 Name. The name of the Trust created hereby is "Calvert Research and Management" and so far as may be practicable the Trustees shall conduct the Trust's activities, execute all documents and sue or be sued under that name, which name (and the word "Trust", whenever used herein) shall refer to the Trustees as Trustees, and not as individuals, or personally, and shall not refer to the officers, agents, employees or holders of shares of beneficial interest of the Trust. Should the Trustees determine that the use of such name is not advisable, they may use such other name for the Trust as they deem proper, and the Trust may hold its property and conduct its activities under such other name. The principal place of business of the Trust shall be Two International Place, Boston, Massachusetts 02110.  
Sections


Section 2.1 is hereby replaced in its entirety with the following:

Section 2.1 Identity and Number of Trustees. Corporations, other forms of entity and individuals may serve as Trustees hereunder. The number of Trustees shall initially be one (1), and thereafter shall be such number as shall be fixed from time to time; provided, however, that the number of Trustees shall in no event be more than ten (10). Eaton Vance, Inc., with a principal place of business at Two International Place, Boston, MA 02110, serves as the sole Trustee on the date of this Declaration.

4. The amendments herein provided for were authorized in accordance with law.


