RELEASE OF TRADEMARK SECURITY AGREEMENT

WHEREAS, pursuant to that certain ASSIGNMENT FOR SECURITY - TRADEMARKS, dated as of March 5, 2015 (the "Trademark Security Agreement") of Intermex Wire Transfer, LLC, a Florida limited liability company (the "Releasee"), pledged, conveyed, sold, assigned, transferred and set over unto MGG Investment Group LP, as the Collateral Agent for itself and certain lenders (in such capacity, together with its successors and assigns, if any, the "Releasor"), and granted to Releasor for the benefit of the Releasor and the Secured Parties, a continuing security interest in all right, title and interest of such Releasee in, to and under the trademarks and service marks listed on the attached Schedule A, which trademarks and service marks are registered or applied for in the United States Patent and Trademark Office (the "Trademarks"), together with, among other things, the goodwill of the business symbolized by the Trademarks and the applications and registrations thereof, and all proceeds thereof, including without limitation, any and all causes of action which may exist by reason of infringement thereof and any and all damages arising from past, present and future violations thereof (collectively, the "Collateral") to secure the prompt payment, performance and observance of the Secured Obligations; and

WHEREAS, Releasee has requested and Releasor has agreed to provide this Release of Trademark Security Agreement to confirm the release, relinquishment and discharge of its continuing security interest in the Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, Releasor hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest. Releasor hereby releases to Releasees, and releases to the Releasee on behalf of the Secured Parties, its continuing security interest in the Collateral.
