**PARTIAL TERMINATION AND RELEASE  
OF  
GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS**

THIS PARTIAL TERMINATION AND RELEASE OF GRANT OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of August 17, 2017, is made by JPMORGAN CHASE BANK, N.A., a national banking association, as Administrative Agent (the "Agent") for the lending and other financial institutions (the "Lenders") from time to time parties to the Credit Agreement, dated as of March 2, 2007 (as amended, the "Credit Agreement"), among DOCTOR ACQUISITION CO., RDA HOLDING CO, THE READER'S DIGEST ASSOCIATION, INC., the Borrowers and Overseas Borrowers from time to time party thereto, the Lenders, the Agent, CITICORP NORTH AMERICA, INC. and MERRILL LYNCH, PIERCE, FENNER & SMITH INCORPORATED, as Co-Syndication Agents, and THE ROYAL BANK OF SCOTLAND PLC, as Documentation Agent.

**WHEREAS**, BOOKS ARE FUN, LTD., an Iowa corporation (the "Releasing Grantor"), certain other grantors party thereto (collectively, the "Grantors" and each, a "Grantor") and the Agent entered into a Grant of Security Agreement in Trademark Rights, dated as of March 2, 2007 (the "Security Agreement"), which Security Agreement was recorded with the United States Patent and Trademark Office on April 27, 2007, at Reel 003530, Frame 0662 for the purpose of collateral security for all indebtedness and obligations of the Grantors to the Agent, for the benefit of the Lenders, arising under the Credit Agreement; and

**WHEREAS**, pursuant to the Credit Agreement, a Guarantee and Collateral Agreement (as defined in the Security Agreement) and the Security Agreement, the Releasing Grantor pledged and assigned to the Agent, and granted the Agent a security interest with power of sale in, certain trademarks, including the trademarks listed on Exhibit A hereto (the "Released Trademarks"); and

**WHEREAS**, the Released Trademarks have been sold, transferred and assigned by the Releasing Grantor to Imagine Nation Books, Ltd., an Iowa corporation, and in connection with such sale, the Agent has agreed to terminate and release its security interest in the Released Trademarks as herein provided;

**NOW, THEREFORE**, for valuable consideration the Agent hereby terminates and releases its security interest in the Released Trademarks listed on Exhibit A hereto, and the Agent hereby assigns and transfers to Imagine Nation Books, Ltd., without representation, warranty or recourse, all of the Agent's right, title and interest in and to such Released Trademarks, effective as of the date set forth above. Except for the Released Trademarks, Agent's security interest in all Trademarks and other Intellectual Property granted and evidenced by the Security Agreement remains in full force and effect.


