TRADEMARK ASSIGNMENT

This ASSIGNMENT, effective as of August ~~22~~2017, is made between Quantum, Inc., an Oregon corporation (the "Assignor"), and Akeso Health Sciences, LLC, a California limited liability company (the "Assignee") with reference to the following:

A. Assignor is the owner of the trademark MIGRELIEF for dietary and nutritional supplements and a nutritional supplement containing feverfew and other natural ingredients for relieving headaches, and U.S. Registration No. 2,002,902 and U.S. Serial Number 86/857160 therefor, and all common law rights associated therewith (the "Mark").

B. A dispute arose between Assignor and Assignee regarding use and ownership of the Mark, which was litigated in the United States District Court for the District of Oregon, Civil No.: 3:16-cv-00334-JE (the "Civil Action").

C. In fulfillment of the Court's Order filed August 8, 2017 in the Civil Action, Quantum is required to assign the Mark to Assignee (the "Order");

D. Assignor has agreed to assign to the Assignee all of the rights, title, and interests of the Assignor in and to the Marks and the Assignee has agreed to accept said assignment.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby conclusively acknowledged:

1. Assignor does hereby sell, assign, transfer and set over to Assignee all its right, title and interest in, to and under the Mark and applications or registrations therefor, together with the goodwill of the business symbolized by the Mark, together with all rights and privileges granted and secured thereby, including the right to sue and recover for any past infringement, said rights to be held and enjoyed by Assignee, for its own use and benefit and for the use and benefit of its successors, assigns or other legal representatives as fully and entirely as the same would have been held and enjoyed by Assignor if this assignment and sale had not been made.

2. In consideration for this Assignment, Assignee shall pay to Assignor the sum of \$100,000, such payment to be satisfied by the reduction of the judgment awarded from Assignor to Assignee in Paragraph 2 of the Order.
