**THIS TERMINATION AND RELEASE OF PATENT AND TRADEMARK SECURITY AGREEMENT** dated as of August 23, 2017, by **NBH CAPITAL FINANCE**, a division of NBH Bank, a Colorado state-chartered bank, formerly known as NBH Capital Finance, a division of NBH Bank, N.A. (together with its successors and assigns, "Lender").

**WHEREAS**, TERRACARE ASSOCIATES, LLC, a Colorado limited liability company ("Borrower") and Lender entered into a Patent and Trademark Security Agreement, dated as of September 4, 2013 (the "Security Agreement") which Security Agreement was recorded with the United States Patent and Trademark Office on November 20, 2013, at Reel 5158, Frame 0005 for the purpose of collateral security for all indebtedness and obligations of Borrower to Lender arising under a certain Loan Agreement (as defined in the Security Agreement);



**NOW, THEREFORE**, for valuable consideration Lender hereby terminates and releases its security interest in the Intellectual Property, including, without limitation, the Trademarks listed on Exhibit A hereto, and Lender hereby assigns and transfers to Borrower, without representation, warranty or recourse, all of Lender's right, title and interest in and to such Intellectual Property, effective as of the date set forth above.

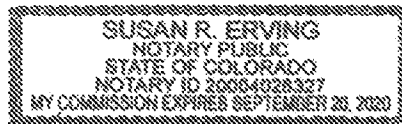
