TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this "*Termination and Release*") is granted as of August 23, 2017 by SILICON VALLEY BANK, as Administrative Agent (the "*Administrative Agent*") in favor of ZIRMED INC., a Delaware corporation ("*ZirMed*"), VERA-FUND, INC., a Kentucky corporation ("*Vera-fund*"), BLUEBONNET, LLC, a Kentucky limited liability company ("*BlueBonnet*"), IHC ACQUISITION, LLC, a Kentucky limited liability company ("*IHC Acquisition*"), MED-PAYMENT.COM, INC., a Kentucky corporation ("*Med-Payment*"), METHODCARE, INC., a Delaware corporation ("*MethodCare*", and together with Med-Payment, IHC Acquisition, BlueBonnet, Vera-fund and ZirMed, each individually and collectively, jointly and severally, the "*Grantor*").

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of September 24, 2014 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"), granting the Administrative Agent a security interest in and lien on certain Trademarks and Trademark applications described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on September 29, 2014, at Reel 5370, Frame 0336;

WHEREAS, Grantor has requested that Administrative Agent hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks and Trademark applications described in the Grant (collectively, the "*Trademarks*") as herein provided; and

WHEREAS, Grantor has requested that the Administrative Agent provide a document suitable for recording in the USPTO to evidence the release of the Administrative Agent's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby:


1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
