TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This **TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of August 25, 2017 by **SILICON VALLEY BANK**, as Administrative Agent (the “*Assignee*”), in favor of **RAIN KING SOFTWARE, INC.**, a Delaware corporation (the “*Grantor*”).

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of September 22, 2015 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Agreement*”), granting the Assignee a security interest in and lien on certain trademarks and trademark applications described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on September 22, 2015, at Reel 5627, Frame 0903;

WHEREAS, the Grantor requests that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the trademarks and trademark applications described in the Agreement (the “*Trademarks*”) as herein provided; and

WHEREAS, Grantor has requested that the Assignee provide a document suitable for recording in the USPTO to evidence the release of the Assignee’s security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Agreement and releases, terminates and discharges fully, without representation, warranty or recourse of any kind, all liens and continuing security interests in each Grantor’s right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
