**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of August 28, 2017 (this "Release"), is made by WELLS FARGO BANK, NATIONAL ASSOCIATION, for itself and on behalf of other holders of Secured Obligations as defined in the Credit Agreement referred to below (in such capacity, together with its successors and assigns, the "Lender"), and GIORGIFRED COMPANY, a Delaware corporation, (together with its successors and assigns, the "Grantor"). Capitalized terms used in this Release and not otherwise defined herein have the meanings specified in the Security Agreement (as defined below).

WHEREAS, Grantor and Lender are parties to a certain Amended and Restated Credit Agreement, dated as of November 7, 2012 (the "Credit Agreement") and a certain United States Trademark Security Agreement dated as of November 13, 2012 (the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, Grantor pledged and granted to Lender a collateral assignment and security interest in and to all of Grantor's right, title and interest in, to and under certain trademarks, trade names, corporate names, company names, business names, fictitious business names, trade dress, service marks, logos, designs, domain names and other source or business identifiers, including, without limitation, those listed on Schedule A hereto (the "Marks"), which Security Agreement was recorded in the United States Patent and Trademark Office (the "USPTO") on November 27, 2012 at Reel 4907 / Frame 0378;

WHEREAS, Grantor and First Union National Bank ("First Union"), a predecessor of Lender, were parties to a certain Trademark Collateral Assignment and Security Agreement dated June 29, 2000 (the "2000 Trademark Security Agreement") under which Grantor pledged and granted to First Union a collateral assignment and security interest in and to certain of Grantor's Marks, which 2000 Trademark Security Agreement was recorded in the USPTO on September 21, 2000 at Reel 2142 / Frame 0962;

WHEREAS, Grantor and Meridian Bank ("Meridian"), a predecessor of Lender, were parties to a certain Security Interest dated January 30, 1991 (the "1991 Security Interest") under which Grantor pledged and granted to Meridian a security interest in and to certain of Grantor's Marks, which 1991 Security Interest was recorded in the USPTO June 17, 1991 at Reel 793 / Frame 0692;

WHEREAS, Grantor has paid off all its loans held by and fulfilled all its obligations owed to Lender, Meridian and First Union, and the parties wish to release Grantor's Marks, including the Marks listed in Schedule A, from any and all security interests held by Lender, Meridian and First Union.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Release of Security Interest. Lender, on behalf of itself, Meridian and First Union, hereby terminates, cancels, releases, and discharges in full any and all liens and security interests that it has in, to and under the Marks. Lender hereby reassigns and transfers any right, title and

interest that Lender may have in the Marks to the Grantor. Lender specifically acknowledges on behalf of itself, Meridian and First Union that, the security interest is no longer effective, and that none of Lender, Meridian, and First Union own any rights to or have any ownership or any other interest in the Marks.


2. Authorization to Record. Lender authorizes and requests that the United States Patent and Trademark Office and any applicable government officer record this Release.

3. Further Assurances. Lender shall take all further actions and provide Grantor, its successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of documents or other instruments), reasonably requested by such Grantor to evidence, record and more fully and effectively effectuate the purposes of this Release, at such Grantor's sole expense.
