**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

THIS TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARK RIGHTS, dated as of August 25, 2017 is made by CITIZENS BANK, NATIONAL ASSOCIATION (formerly known as RBS Citizens, N.A.), as Administrative Agent, (the "Administrative Agent"), under that certain Notice of Grant of Security Interest in Trademarks entered into by BackOffice Associates, LLC, a Delaware limited liability company (the "Borrower") in favor of the Administrative Agent, pursuant to that certain Security Agreement, dated as of December 20, 2012, by and among the Obligors (as defined therein) party thereto and the Administrative Agent (as amended, supplemented or modified and in effect from time to time, the "Security Agreement").

WHEREAS, pursuant to the Security Agreement, the Borrower granted a security interest to the Administrative Agent in certain intellectual property collateral including the Trademarks (as defined in the Security Agreement), including, without limitation, those Trademarks set forth on Schedule 1 thereto (the "Trademark Collateral");

WHEREAS, an executed copy of the Notice of Grant of Security Interest in Trademarks was recorded with the Trademark Assignment Recordation Branch of the United States Patent and Trademark Office (the "USPTO") on July 14, 2014 at Reel 5321, Frame 0863; and


WHEREAS, the Administrative Agent has agreed to terminate and release its security interest in all of such Trademarks, including, without limitation, the Trademarks identified on Schedule A attached hereto, and to provide this document suitable for recording in the USPTO evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Administrative Agent does hereby, in each case, without recourse, representation or warranty of any kind whatsoever, (a) terminate the liens and security interest created under the Security Agreement in the Trademark Collateral, (b) release its security interest in the Trademark Collateral, and (c) discharge and reassign to the Borrower any and all rights, title and interest it has in and the security interest granted to the Administrative Agent in the Trademark Collateral. The Administrative Agent authorizes and requests that the Commissioner for Trademarks of the USPTO and any other applicable government officer or relevant governmental authority record this Termination and Release of Security Interest in Trademark Rights.
