## RELEASE OF SECURITY INTEREST

This Release of Security Interest ("Release") is made by and between URSA MINOR B.V., a corporation formed under the laws of the Netherlands ("Pledgor") and ROSENTHAL & ROSENTHAL, INC., a New York corporation ("Secured Party") concerning an Intellectual Property Security Agreement dated September 30, 2013 ("Agreement"), in which to secure certain obligations of Pledgor, Pledgor granted to Secured Party a security interest in the trademarks, set forth in Schedule A (the "Marks"), recorded at reel/frame 5121/0326.


NOW THIS RELEASE WITNESSETH that:

3. This Release may not be changed except in a writing signed by the party against whose interest such change shall operate. This Release shall be governed by and construed under the laws of the State of New York without regard to principles of conflicts of law.
