## **TRADEMARK RELEASE**

This TRADEMARK RELEASE is made as of August 28, 2017, by GOLUB CAPITAL LLC, as Administrative Agent (in such capacity, "Grantee"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

### **W I T N E S S E T H:**

WHEREAS, each of Accellos, Inc., a Delaware corporation, HighJump Software, Inc., a Delaware corporation, HighJump Software I, Ltd., a Delaware corporation, PROFITSystems, Inc., a Colorado corporation, and True Commerce, Inc., a Delaware corporation (collectively, the "Grantors"), and Grantee are parties to that certain Trademark Security Agreement dated as of July 2, 2014 (the "Trademark Security Agreement") and that certain Security Agreement dated as of July 2, 2014, pursuant to which each Grantor granted a security interest to Grantee in certain Trademarks and Trademark Collateral (as defined therein) as security for certain obligations owing by such Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on July 2, 2014, at Reel 5314, Frame 0861; and

WHEREAS, Grantors have requested that Grantee release its security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantors' right, title and interest in and to the following:

- (i) each Trademark registration and Trademark application owned by Grantors, including, without limitation, the Trademark registrations and Trademark applications referred to in Schedule 1 annexed hereto;
- (ii) all goodwill associated with or symbolized by each such Trademark; and
- (iii) all products and Proceeds of the foregoing.

2. Grantee hereby releases its security interest in the Trademark Collateral and reassigns, grants and conveys to Grantors, without any representation, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Trademarks and the Trademark Collateral. The Grantee hereby agrees, at the expense of the Grantors, to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably requested to effect the release of the security interests contemplated hereby.
