TRADEMARK ASSIGNMENT AGREEMENT

This Trademark Assignment Agreement (the "**Agreement**") is entered into on 6th day of May, 2015 (the "**Effective Date**") by and between MonaVie LLC, a limited liability company, duly organized and existing under the laws of the State of Delaware and having a principal place of business at 10855 S. River Front Parkway, Suite 100, South Jordan, Utah 84095 ("**Assignor**") and Jeunesse Global Holdings, LLC, a limited liability company, duly organized and existing under the laws of the State of Florida and having a principal place of business at 650 Douglas Avenue, Suite 1020, Altamonte Springs, Florida, 32714 ("**Assignee**") Assignor and Assignee are also referred to herein individually as "**Party**" and collectively as "**Parties**." This Agreement memorializes the Strict Foreclosure Agreement that was duly signed on the Effective Date.

WHEREAS, Assignor has adopted, used and owns the entire right, title and interest in and to certain U.S. and foreign trademarks and services marks, both registered and unregistered, and applications for trademark and service marks filed with the United States Patent and Trademark Office and other foreign trademark offices, as identified in Exhibit A, attached hereto (collectively the "**Marks**");


WHEREAS Assignee desires to acquire all of Assignor's right, title and interest, in and to the Marks together with all the goodwill of the business symbolized thereby, and Assignor desires to assign all such right, title and interest in and to the Marks to Assignee; and

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged by Assignor, the parties agree as follows:

1. Assignor hereby conveys and assigns to Assignee, and Assignee hereby accepts from Assignor, all of Assignor's right, title and interest in and to the Marks, under both foreign and domestic uses, together with the goodwill of the business symbolized by the Marks;
2. Assignor conveys and assigns, without limitation, the right to own and to prosecute in Assignee's own name any applications for registration in the United States of America and foreign countries; and
3. Assignor conveys and assigns the right to prosecute, litigate and/or pursue existing litigation and causes of action, if desired, now in existence or arising in the future resulting from acts of infringement relating to the Marks, including the right to sue and recover for past or present infringement, and the sole right to settle such causes of action.

IN WITNESS WHEREOF, the parties hereto have caused this Agreement to be executed by their respective duly authorized representatives as of the Effective Date.
