ASSIGNMENT AGREEMENT




1. 2. This assignment includes the right to collect royalties in connection with the Trademarks and all rights to sue for past, present, or future infringement of the Trademarks and to recover damages or lost profits, as well as the rights to pursue or defend any oppositions that have been filed based on the Trademarks, against trademark applications filed by third parties.
3. Regarding Application No. 85195174, the assignment of rights is together with the portion of the business to which the trademark pertains.
4. The undersigned persons, being the representatives of the Assignor and the Assignee, have full power and authority to sign this assignment on behalf of the Assignor and the Assignee.
5. This Assignment shall be binding on the Assignor and the Assignee, and their respective heirs, successors and permitted assigns.
