TRADEMARK RELEASE

This TRADEMARK RELEASE is made as of August 28, 2017, by GOLUB CAPITAL LLC, as Administrative Agent (in such capacity, "Grantee"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Trademark Security Agreement (as defined below).

WITNESSETH:

WHEREAS, Redtail Solutions, Inc., a Delaware corporation (the "Grantor"), and Grantee are parties to that certain Trademark Security Agreement dated as of March 28, 2017 (the "Trademark Security Agreement") and that certain Security Agreement dated as of July 2, 2014, pursuant to which Grantor granted a security interest to Grantee in certain Trademarks and Trademark Collateral (as defined therein) as security for certain obligations owing by Grantor to Grantee, including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 29, 2017, at Reel 6022, Frame 0058; and

WHEREAS, Grantor has requested that Grantee release its security interest in the Trademarks and Trademark Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Grantee hereby releases its security interest in all of Grantor's right, title and interest in and to the following:

- (i) each Trademark registration and Trademark application owned by Grantors, including, without limitation, the Trademark registrations and Trademark applications referred to in Schedule 1 annexed hereto;
- (ii) all goodwill associated with or symbolized by each such Trademark; and
- (iii) all products and Proceeds of the foregoing.


