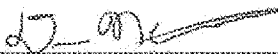
Pursuant to Section 242 of the General Corporation Law of the State of Delaware, Vitec Broadcast Services Inc. (the "*Corporation*"), a corporation organized and existing under the laws of the State of Delaware, does hereby certify as follows:

1. The Certificate of Incorporation of the Corporation was filed with the Secretary of State of Delaware on June 16, 1993;
