## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**, dated as of August 22, 2017 (the "Release"), is made by ANTARES CAPITAL LP (successor to General Electric Capital Corporation), as Collateral Agent (the "Collateral Agent") in favor of NAVEX GLOBAL, INC., a Delaware corporation and NAVEX GLOBAL HOLDING COMPANY, a Delaware corporation (each individually a "Pledgor" and, collectively, the "Pledgors"). All capitalized terms used but not otherwise defined herein have the meanings assigned to them in the Security Agreement (as defined below), or if not defined therein, in the Credit Agreement (as defined below), as applicable.

### WITNESSETH

WHEREAS, the Pledgors and the Collateral Agent entered into that certain Second Lien Security Agreement, dated as of November 20, 2014 (as amended, restated, supplemented, waived or otherwise modified from time to time, the "Security Agreement");

WHEREAS, pursuant to the Security Agreement, the Pledgors executed the (i) Second Lien Trademark Security Agreement dated as of November 20, 2014 (the "Trademark Security Agreement") and recorded with the U.S. Patent and Trademark Office ("USPTO") on November 20, 2014 at Reel/Frame Nos. 5405/0428 and 5405/0435 and the (ii) Second Lien Copyright Security Agreement dated as of November 20, 2014 (the "Copyright Security Agreement") and recorded with the U.S. Copyright Office ("USCO") on November 24, 2014 at V9918 D974, pursuant to which the Pledgors pledged and granted to the Collateral Agent for the benefit of the Secured Parties a Lien on and security interest in and to all of its right, title and interest in, to and under all of the Trademark Collateral (as defined in the Trademark Security Agreement) and Copyright Collateral (as defined in the Copyright Security Agreement); and

WHEREAS, pursuant to the Second Lien Assignment of Intellectual Property Security Agreement dated as of August 21, 2015 (the "Assignment") and recorded August 31, 2015 with the USPTO at Reel/Frame No. 5612/0171 and recorded with the USCO on September 3, 2015 at V9908 D705, General Electric Capital Corporation assigned and transferred to Antares Capital LP and its successors and assigns, all of its rights, title and interest in and to the Trademark Security Agreement and the Copyright Security Agreement.


WHEREAS, the Pledgors have requested that the Collateral Agent release its security interest in all right, title and interest in, to and under all of the Trademark Collateral and Copyright Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Collateral Agent hereby **DISCHARGES, TERMINATES and RELEASES**, without recourse, representation or warranty, its security interest in all right, title and interest in, to and under all of the Trademark Collateral and Copyright Collateral, including the trademark registrations, trademark applications, and copyright registrations set forth in Schedule I attached hereto and incorporated herein by reference, and agrees that all the security interest in the Trademark Collateral and Copyright Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Pledgors, without recourse, representation or warranty, any and all right, title and interest that the Collateral Agent may have obtained in, to and under the Trademark Collateral and Copyright Collateral under the Security Agreement, the Trademark Security Agreement, the Copyright Security Agreement, and the Assignment.


