# Trademark Assignment

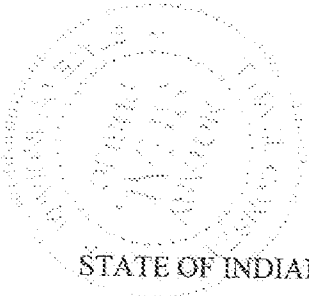
