TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of August 28, 2017, by WELLS FARGO BANK, NATIONAL ASSOCIATION, as administrative agent (“Grantee”), in favor of DIESEL DIRECT, INC., a Massachusetts corporation (the “Grantor”).

WHEREAS, pursuant to the terms and conditions of (i) that certain Trademark Security Agreement, dated as of March 4, 2014 (the “Trademark Security Agreement”; capitalized terms used herein but not otherwise defined herein shall have the meanings given to them in the Trademark Security Agreement), and (ii) the Loan and Security Agreement, Grantors granted to Grantee for the benefit of the Secured Parties a security interest in substantially all of the assets of Grantors including all right, title and interest of Grantors in, to and under all then owned and thereafter acquired Trademark Collateral; and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on March 4, 2014 at Reel 5230 Frame 0157.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Grantee hereby (i) terminates the Trademark Security Agreement, and (ii) releases, without any representation, recourse or undertaking by Grantee, any and all liens on and security interests in the Grantors’ Trademark Collateral granted pursuant to the Trademark Security Agreement and/or the Loan and Security Agreement, including the Trademark Collateral listed on Schedule 1 hereto.


