

TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT

This Termination and Release Agreement, dated and made effective as of August 11, 2017 (this "Agreement"), is between Omniplex World Services Corporation ("Releasee") and PNC Bank, National Association in its capacity as agent for the Lenders (the "Security Agent").

WHEREAS, by that certain Trademark Security Agreement dated May 20, 2016, made by Releasee in favor of Security Agent (the "Security Agreement") recorded at the U.S. Patent and Trademark Office on May 26, 2016 at Reel 5801, Frame 0297, Releasee granted to Security Agent a security interest in and to the following U.S. Trademark Registrations:

Reg. No. 2,859,769 RIGHT PEOPLE, RIGHT VALUES

Reg. No. 3,896,811 OMNIPLEX WORLD SERVICES CORPORATION

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, the parties to this Agreement hereby agree as follows.

Section 1. Termination and Release of Security. Effective as of the date of this Agreement, the Security Agreement is terminated and of no further force and effect.

Section 2. Release of Liens and Indemnity. The Security Agent hereby confirms that the security interest created in the U.S. Trademark Registrations listed above are hereby released without further act or requirement, and terminated as of the date of this Agreement.

Section 3. GOVERNING LAW. THIS AGREEMENT SHALL BE GOVERNED BY, AND CONSTRUED AND ENFORCED IN ACCORDANCE WITH, THE INTERNAL SUBSTANTIVE LAWS OF THE STATE OF NEW YORK, WITHOUT GIVING EFFECT TO THE CONFLICT OF LAW RULES THEREOF.
