**RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS AND
TRADEMARK RIGHTS**

This RELEASE OF GRANT OF SECURITY INTEREST IN PATENTS AND TRADEMARK RIGHTS ("Release"), effective as of this 20th day of July, 2017, is made by **Enhanced Small Business Investment Company, LP**, with an address at 600 Lexington Ave., 14th Floor, New York, New York 10022, as collateral agent (in such capacity, together with its successors and permitted assigns, the "Collateral Agent") for the Secured Parties, in favor of Taste, Inc., a California corporation with an address of 360 22nd Street, Suite 640, Oakland, California 94612 (the "Grantor"), as follows:

WITNESSETH

WHEREAS, the Grantor, certain affiliates of the Grantor party thereto from time to time, the financial institutions party thereto from time to time and the Collateral Agent are parties to that certain Senior Loan Agreement, dated as of December 22, 2015 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Credit Agreement");

WHEREAS, in connection with the Credit Agreement, the Grantor and certain other affiliates of Grantor have executed and delivered a Security Agreement, dated as of December 22, 2015, in favor of the Collateral Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the "Security Agreement")

WHEREAS, pursuant to the Security Agreement, the Grantor pledged and granted to the Collateral Agent a security interest in and to all Grantor's right, title and interest in all of its Intellectual Property, including the patents and trademarks as set forth on Schedule A attached hereto (collectively, the "Patent and Trademark Collateral") to secure the Obligations (as defined in the Security Agreement);

WHEREAS, in furtherance of the Security Agreement, the Grantor executed that certain Grant of Security Interest in Patents and Trademark, dated as of December 22, 2015 (as amended, supplemented or otherwise modified from time to time, the "Patent and Trademark Security Agreement"), which was duly recorded on December 28, 2015 at Reel/Frame 5697/0630 and Reel/Frame 037366/0526 in the United States Patent and Trademark Office.

WHEREAS, the Collateral Agent wishes to release and restore all right, title and interest in and to the Trademark Collateral to the Grantor and to dissolve those liens and encumbrances created by the Patent and Trademark Security Agreement and the Credit Agreement in respect of the Patent and Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, the Collateral Agent hereby grants, assigns and conveys, without recourse or warranty, to the Grantor all of its rights, title and interest in the Patent and Trademark Collateral, and terminates, releases, discharges, quitclaims and relinquishes unto the Grantor any and all security interests and liens it has against the Patent and Trademark Collateral.
