**RELEASE OF
GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS**

THIS RELEASE OF GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Release"), is dated as of September 1, 2017, and made by **CIT FINANCE LLC**, in its capacity as Agent under the below-defined Security Agreement, having an office at 11 West 42nd Street, New York, New York 10036 ("Grantee") to **PETPEOPLE ENTERPRISES, LLC**, an Ohio limited liability company ("Grantor"), with its chief executive office at 4390 Reynolds Drive, Hilliard, Ohio 43026-1260.

WHEREAS, pursuant to that certain Grant of Security Interest in United States Trademarks dated as of June 30, 2014, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 7, 2014, at Reel 5317 and Frame 0191; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Release, Grantee hereby states as follows:


1. Definitions. The term "Trademark Collateral", as used herein, shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Trademark Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Trademark Collateral.
