RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS dated September 1, 2017 by Fifth Third Bank, an Ohio banking corporation ("*Fifth Third*"), acting as administrative agent hereunder for the Secured Parties as defined in the Agreement referred to below (Fifth Third acting as such administrative agent being hereinafter referred to as the "*Agent*");

WITNESSETH:

WHEREAS, SEQUEL TSI HOLDINGS, LLC, an Iowa limited liability company ("*Debtor*"), with its mailing address at 1131 Eagletree Lane, Huntsville, Alabama 35801 and Agent were parties to a certain Trademark Security Agreement dated December 23, 2009, between Debtor and Agent which was recorded in the United States Patent and Trademark Office (the "*USPTO*") on January 14, 2010 at Reel 4131, Frame 0672 or the Arizona Secretary of State, as applicable (the "*Agreement*"), pursuant to which Debtor granted to Agent, a continuing security interest in, among other things, the trademarks, trademark registrations, and trademark applications listed on Schedule A attached hereto and certain other property as set forth in the Agreement (collectively, the "*Trademark Property*") to secure the payment and performance of all Obligations of Debtor as set out in that certain Agreement; and

WHEREAS, Debtor has requested that Agent release its continuing security interests in the Trademark Property and reassign the same to Debtor;

NOW, THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. All capitalized terms used herein but not defined shall have the meanings ascribed to them in the Agreement.

2. Agent hereby releases its continuing security interests in, and hereby reassigns, grants and conveys to Debtor, without any representation, warranty, recourse or undertaking by Agent, all of its right, title and interest, if any, in and to each trademark, trademark registration, and trademark application listed on Schedule A hereto, including:

(i) each trademark, trademark registration, and trademark application listed on Schedule A hereto, and all of the goodwill of the business connected with the use of, and symbolized by, each such trademark, trademark registration, and trademark application; and

(ii) all proceeds of the foregoing, including without limitation any claim by Debtor against third parties for damages by reason of past, present or future infringement of any trademark, trademark registration, or trademark application listed on Schedule A hereto or by reason of injury to the goodwill associated with any such trademark, trademark registration, or trademark application, in each case together with the right to sue for and collect said damages.

3. Agent hereby authorizes Debtor, its successors, assigns and representatives to record this document at the USPTO or the Arizona Secretary of State, as applicable.
