2. Authorizes and requests the Commissioner of Patents and Trademarks of the United States to issue or transfer all of the MARKS to ASSIGNEE, as assignee of the entire right, title, and interest therein or otherwise as the ASSIGNEE may direct.

WHEREAS, in the event the assignment by way of the Purchase Agreement is, in any way, deemed invalid, the ASSIGNOR and ASSIGNEE further agree:

WHEREAS, ASSIGNEE is desirous of acquiring and ASSIGNOR is willing and able to assign all of ASSIGNOR's right, title and interest in and relating to the MARKS and any other marks similar thereto, together with all business goodwill associated therewith;




