**RELEASE OF SECURITY INTEREST IN
TRADEMARK COLLATERAL**

This RELEASE, dated as of August 25, 2017, is made by Summit Financing LLC (the "Secured Party"), in favor of Fairway & Greene, Ltd. (the "Grantor") as follows:

WITNESSETH

WHEREAS, pursuant to (a) Trademark Security Agreement dated as of September 27, 2004 between Fairway & Greene, Ltd. and People's United Bank (formerly known as People's Bank), recorded October 1, 2004 at Reel/Frame: 2950/0070 (the September 2004 Collateral Agreement"), (b) Trademark Security Agreement dated as of December 29, 2005 between Fairway & Greene, Ltd. and People's United Bank (formerly known as People's Bank), recorded March 29, 2006 at Reel/Frame: 3280/0862 (the "December 2005 Collateral Agreement"), (c) Trademark Security Agreement dated as of November 20, 2007 between Fairway & Greene, Ltd. and People's United Bank, recorded December 10, 2007 at Reel/Frame: 3676/0479 (the "November 2007 Collateral Agreement") and (d) Notice of Grant of Security Interest in Trademarks dated as of November 20, 2007 between Fairway & Greene, Ltd. and People's United Bank, recorded August 24, 2009 at Reel/Frame: 4051-0638 pursuant to that certain Trademark Security Agreement dated as of November 20, 2007 (the "November 2007 Notice" and collectively with the September 2004 Collateral Agreement, the December 2005 Collateral Agreement and the November 2007 Collateral Agreement, the "Collateral Agreements"), the Grantor granted People's a continuing security interest in all of its right, title and interest in, to and under the trademarks (i) "Clothes That Respect the Game", U.S. Patent and Trademark Office Registration No. 2,090,179, (ii) "Fairway & Greene", U.S. Patent and Trademark Office Registration No. 2,039,538 and (iii) "Respect For the Game", U.S. Patent and Trademark Office Registration No. 2,046,697 (collectively, the "Released IP Collateral");

WHEREAS, the Collateral Agreements were assigned by People's to Secured Party, pursuant to that Assignment of Security Interest in Trademarks and Service Marks dated March 28, 2014, a copy of which is attached hereto as Exhibit A; and

WHEREAS, the Grantor has requested that the Secured Party release, and confirm the release of, its liens on and security interest in all right, title and interest in, to and under the Released IP Collateral.

NOW, THEREFORE, the Secured Party, without recourse to it or representation or warranty by it, and at the Grantor's sole cost and expense, hereby terminates, cancels and releases and confirms the termination, cancellation and release of its liens on and security interest in the Released IP Collateral, and any and all right, title and interest of the Secured Party in the Released IP Collateral shall and is hereby confirmed to be terminated, ceased and voided.

The Secured Party agrees to provide the Grantor with any information and additional authorization and documentation necessary to effect the release of the Secured Party's security

interest in the Released IP Collateral (without recourse to it or representation or warranty by it, and at the Grantor's sole cost and expense).
