TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTERESTS IN TRADEMARKS** (this "*Termination and Release*") is granted as of September 1, 2017 by SILICON VALLEY BANK, as Assignee (the "*Assignee*"), in favor of Therapeutic Research Holdings, LLC, a Delaware limited liability company ("*Holdings*"), Therapeutic Research Center, LLC, a Delaware limited liability company ("*Center*"), Therapeutic Research Center II, LLC, a Delaware limited liability company ("*Center II*"), Therapeutic Research Faculty, LLC, a Delaware limited liability company ("*Faculty*"), and Professional Faculty, LLC, a California limited liability company ("*Professional*", and together with Holdings, Center, Center II and Faculty, each individually and collectively, jointly and severally, the "*Grantor*").

WHEREAS, the Grantor executed and delivered a Trademark Security Agreement, dated as of August 6, 2012 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the "*Grant*"), granting the Assignee a security interest in and lien on certain Trademarks and Trademark applications described therein, which was recorded with the United States Patent and Trademark Office ("*USPTO*") on August 7, 2012, at Reel 4837, Frame 0734;

WHEREAS, Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of Grantor in, to and under all of the Trademarks (as defined in the Grant) as herein provided; and

WHEREAS, Grantor has requested that the Assignee provide a document suitable for recording in the USPTO to evidence the release of the Assignee's security interests in and liens on the Trademarks as herein provided.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in Grantor's right, title and interest in, to and under the Trademarks, and all goodwill associated therewith, including those Trademarks identified in Schedule I hereto; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.

THIS TERMINATION AND RELEASE AND ANY CLAIM, CONTROVERSY, DISPUTE OR CAUSE OF ACTION (WHETHER IN CONTRACT OR TORT OR OTHERWISE) BASED UPON, ARISING OUT OF OR RELATING TO THIS TERMINATION AND RELEASE AND THE TRANSACTIONS CONTEMPLATED HEREBY SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAW OF THE STATE OF NEW YORK.
