RELEASE AND REASSIGNMENT OF  
INTELLECTUAL PROPERTY

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Grantee hereby terminates the Agreement and releases, retransfers and reassigns to Grantors without representation or warranty, any and all liens, security interests, right, title and interest of Grantee in and to the Marks and the goodwill associated therewith and the Patents.
