## TRADEMARK ASSIGNMENT

This Trademark Assignment is made as of June 19, 2017, between Scott Wilson Design, Ltd., an Illinois company having its principal place of business at 939 West Lake Street, Chicago, Illinois ("Assignor") and Third Estate, LLC, an Indiana company having its principal place of business at 112 W. 9TH St., Suite 726, Los Angeles, CA 90015 ("Assignee").

WHEREAS, Assignor is the owner of the MNML trademark for use with various goods and services, including goods in International Class ("I.C.") 25 and services in I.C. 42;

WHEREAS, Assignor is the owner of U.S. trademark Registration No. 4,486,458 ("the Registration"), which covers the MNML mark for use with goods in I.C. 25 and services in I.C. 42;


WHEREAS, Assignor is desirous of assigning its right, title and interest in and to the MNML mark for use only with I.C. 25 goods, including those set forth in the Registration, to Assignee, and WHEREAS Assignee is desirous of acquiring said right, title and interest.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee all right, title, and interest in and to the MNML mark for use only with I.C. 25 goods, which expressly includes:

- 1) that portion of the Registration that covers goods in I.C. 25; and,
- 2) all business goodwill Assignor has accrued as of the effective date of this Assignment in association with its use of the MNML mark with I.C. 25 goods.

Assignor hereby authorizes and requests the Commissioner of Trademarks to record Assignee as the owner of the MNML mark with respect to the I.C. 25 goods listed in the Registration, which shall be set forth in a second registration to be divided out from the Registration. The Registration shall retain the I.C. 42 services, the rights to which, with respect to the MNML mark, shall remain with Assignor.
