SIXTH: The Agreement of Merger is on file at 345 East Main Street, Warsaw, Indiana 46580, the place of business of the surviving limited liability company.

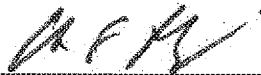
SEVENTH: A copy of the agreement of merger will be furnished by the surviving foreign limited liability company, on request and without cost, to any member of any constituent limited liability company.
