Pursuant to Section 251 of the General Corporation Law of the State of Delaware

Teradata US, Inc., a Delaware corporation (the "**Company**"), does hereby certify the following information relating to the merger of StackIQ, Inc., a Delaware corporation ("**Merger Sub**"), with and into the Company (the "**Merger**"), with the Company continuing as the surviving corporation following the Merger (the "**Surviving Corporation**"):

FIRST: The name and state of incorporation of each of the constituent corporations that is a party to the Merger are as follows:
