THIS ASSIGNMENT is dated 31 May 2017

BETWEEN:

- (1) **NOVARTIS CONSUMER HEALTH S.A.**, a company incorporated under the laws of Switzerland with registered number CHE-102.429.188 and whose registered office is at Route de l'Etraz, 1197 Prangins, Switzerland (the **Assignor**); and
- (2) **LIL' DRUG STORE PRODUCTS, INC.**, an Iowa (USA) corporation with its principal office at 1201 Continental Place NE, Cedar Rapids, IA 52402 (the **Assignee**).

BACKGROUND

- (A) The Assignor is the proprietor of the Trade Marks, the Product Intellectual Property Rights and the Trade Dress (each as defined below).
- (B) As part of an agreement dated 2017 between Seller and the Assignee (**Asset Purchase Agreement**), the Assignor agreed to transfer the Trade Marks, Product Intellectual Property Rights and the Trade Dress to the Assignee.
- (C) The parties now wish to give full effect to the Asset Purchase Agreement by entering into this assignment.

IT IS AGREED:

1. Interpretation

In this assignment:

Completion means completion of the sale and purchase of the several assets to be sold by the Seller to the Assignee in accordance with the Asset Purchase Agreement;

GSK Group means GlaxoSmithKline PLC and each of its subsidiaries (other than the Seller's Group);

GSK House Style means the relevant part of the Trade Dress of the Product which is intended to communicate to the public that the Product originates from the Seller's Group or the GSK Group, including any design, logo or other feature that is used in such presentation of any products (other than the Product), sold by a member of the Seller's Group or the GSK Group at Completion;

Intellectual Property Rights means:

- (a) copyright, patents, database rights and rights in trade marks, designs, know-how and confidential information (whether registered or unregistered);
- (b) applications for registration, and the right to apply for registration, for any of these rights; and
- (c) all other intellectual property rights and equivalent or similar forms of protection existing anywhere in the world;

Novartis Group means Novartis AG and each of its subsidiaries;

Novartis House Style means the relevant part of the Trade Dress of the Product which is intended to communicate to the public that the Product originates from the Novartis Group, including any design, logo or other feature that is used in such presentation of any products (other than the Product) sold by a member of the Seller's Group or the Novartis Group at Completion;

Product means the product set out in Schedule 2 in respect of the Territory listed alongside such Product;

Product Intellectual Property Rights means the Intellectual Property Rights (other than the Trade Marks) owned by the Assignor subsisting in and relating exclusively to the Product;

Seller means GlaxoSmithKline Consumer Healthcare Holdings Limited;

Seller's Group means the Seller and each of its subsidiaries from time to time;

Territory means in relation to the Product, the country set out opposite the name of that Product in Schedule 2;




Trade Dress means, in respect of the Product, the layout, designs and colouring of any external or internal packaging for that Product in the Territory, including labelling and patient information leaflets, but excluding any GSK House Style or Novartis House Style for that Product (as applicable); and





Trade Marks means the registered trade marks set out in Schedule 1.

2. In consideration of payment by the Assignee as set out in the Asset Purchase Agreement, the Assignor hereby assigns to the Assignee such right, title and interest as it holds in the Trade Marks, Product Intellectual Property Rights and the Trade Dress together with all goodwill associated with the use of the Trade Marks, Product Intellectual Property Rights and Trade Dress.
3. This assignment does not include the right to bring action or claim relief in respect of any infringement of the Trade Marks before the date of this assignment.
4. The Assignor agrees, at the request and expense of the Assignee, to sign any documents and to do all other things which the Assignee reasonably considers to be necessary to give effect to this assignment as soon as reasonably practicable including, in the case of UK Trade Marks, to enable the Assignee to record their assignment in the records of the United Kingdom Trade Mark Registry, and, in the case of non-UK Trade Marks, to enable the Assignee to fulfil all relevant national registry requirements for the recordal of the assignment of the Trade Marks in those registries.
5. The Assignee acknowledges that the Assignor gives no representation, warranty, indemnity or guarantee in respect of the Trade Marks, Product Intellectual Property Rights and Trade Dress in this assignment, but this is without prejudice to the provisions of the Asset Purchase Agreement.
6. This assignment and any non-contractual obligations arising out of or in connection with it shall be governed by English law. The English courts have exclusive jurisdiction to settle any dispute arising out of or in connection with this assignment (including a dispute relating to any non-contractual obligations arising out of or in connection with this assignment) and the parties submit to the exclusive jurisdiction of the English courts. The Assignee irrevocably appoints Law Debenture Corporate Services Limited of 5th Floor, Wood Street, London, EC2V 7EX, England as its agent in England for service of process.


