TRANSFER AND ASSIGNMENT OF INTELLECTUAL PROPERTY

- d. The trademark application for the mark "UCALL," filed with the United States Patent and Trademark Office on December 14, 2015, U.S. Serial Number 86847747.

2. "Intellectual Property" also includes, collectively, copyrights, including all registered and unregistered copyrights, copyrightable works, and writings and other works of authorship embodied in tangible form, including any applications relating to any of the foregoing, as applicable, and any renewals of any of the foregoing; know-how, including unpatented technical information, designs, knowledge, know-how and data; patents, including any and all patents and patent applications, any continuing applications thereof including divisionals, continuations, continuations-in-part, reissued and reexamined patents, and all corresponding foreign patents or patent applications; and trademarks and trade dress, including all registered and unregistered trademarks, trade dress, service marks, and logotypes, including any applications relating to any of the foregoing, as applicable, and any renewals of any of the foregoing.

3. For good and valuable consideration, the receipt of which is hereby acknowledged, Assignor hereby assigns and transfers to Assignee all of Assignor's interest in the Intellectual Property, including the associated goodwill, together with all derivative rights and all rights to secure registrations, renewals, reissues, and extensions of the copyrights, patents, and trademark rights included therein, if any.

4. Assignor hereby covenants, warrants, and represents to Assignee that:

- a. Assignor is the sole owner of and has the exclusive right to hold, use, assign, and transfer the Intellectual Property, free and clear of any liens, encumbrances, licenses, or claims of any nature, and has made no agreement, assignment, or other transfer with respect to the Intellectual Property that is in conflict with this Assignment.
- b. Except as specified in Paragraph 1 of this Assignment, no registration has been effected or is on file with the appropriate governmental agencies with respect to the Intellectual Property.
- c. Assignor agrees to authorize and direct his, her, or its heirs, personal representatives, successors, and assigns to make and execute any instrument and to perform any act that Assignee may deem necessary to perfect this Assignment and to secure the registration, renewal, or extension of the registration of the Intellectual Property, as applicable.
- d. Assignor agrees to take such steps and make such filings as may be necessary or appropriate in the determination of Assignee to effect the transactions contemplated hereby.

5. This Assignment is governed by the laws of the State of California without regard to its conflict of law rules. This Assignment constitutes the entire agreement of the parties with respect to the subject matter hereof and may not be modified or amended without the written agreement of the parties.
