**CERTIFICATE OF AMENDMENT OF CERTIFICATE OF
INCORPORATION OF THE ROBERT ALLEN GROUP, INC.**

The Robert Allen Group, Inc. (the "Corporation"), a corporation organized and existing under the General Corporation Law of the State of Delaware, hereby certifies as follows:

1. This Certificate of Amendment (the "Certificate of Amendment") amends the provisions of the Corporation's Certificate of Incorporation filed with the Secretary of State on August 11, 1986 (the "Certificate of Incorporation").
