RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of September 3, 2017, by (a) Mortimer B. Zuckerman 1983 Family Trust u/a/d December 21, 1983, Eric Gertler and James Gertler, Trustees, as secured party (the “**Note A Secured Party**”), (b) The MBZ 1996 Trust u/a/d January 1, 1996 (GST Exempt), as amended, Zuckerman PTC, LLC, Trustee, as secured party (the “**Note B Secured Party**”), and (c) The MBZ 1996 Trust u/a/d January 1, 1996 (GST Non-Exempt), as amended, Zuckerman PTC, LLC, Trustee, as secured party (the “**Note C Secured Party**”, and together with the Note A Secured Party and Note B Secured Party, the “**Secured Parties**”) in favor of (b) Daily News, L.P., a Delaware limited partnership (“**Grantor**”).

RECITALS:

A. Pursuant to the Trademark Security Agreement dated as of September 19, 2016, by and among the Secured Parties and the Grantor (the “**Trademark Security Agreement**”) recorded on October 11, 2016, on Reel No. 5898, Frame 0430 in the United States Patent and Trademark Office, the Grantor granted a security interest in certain trademarks in favor of the Secured Parties to secure certain obligations owing from Grantor to the Secured Parties;

B. The Grantor has requested that the Secured Parties (i) terminate and release the liens and interests of Grantor in (a) certain of Grantor’s trademarks as set forth in Exhibit A attached hereto (collectively, the “**Trademarks**”), (b) all goodwill of the business connected with the use of, and symbolized by, each Trademark and (ii) execute and deliver evidence of such termination and release for filing in the United States Patent and Trademark Office and other appropriate offices; and


C. The Secured Parties have agreed to such release and termination.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Secured Party hereby releases and terminates its security interests in the following, and reassigns to Grantor all right, title and interest of such Secured Party in and to the following: (i) each Trademark (as defined in the Security Agreement referred to in the Trademark Security Agreement) owned by the Grantor, including, without limitation, each Trademark registration and application referred to in Exhibit A hereto, and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark; (ii) each Trademark License (as defined in the Security Agreement referred to in the Trademark Security Agreement) to which the Grantor is a party and all of the goodwill of the business connected with the use of, or symbolized by, each Trademark licensed pursuant thereto; and (iii) all proceeds of and revenues from the foregoing, including, without limitation, all proceeds of and revenues from any claim by the Grantor against third parties for past, present or future unfair competition with, or violation of intellectual property rights in connection with or injury to, or infringement or dilution of, any Trademark owned by the Grantor (including, without limitation, any Trademark identified in Exhibit A hereto), and all rights and benefits of the Grantor under any Trademark License, or for injury to the goodwill associated with any of the foregoing.
