RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This **RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL** (the “Release”) is dated as of September 8, 2017 by WILMINGTON TRUST, NATIONAL ASSOCIATION, a national banking association (“Wilmington Trust”), in its capacity as Collateral Agent (as defined in the Indenture) (in such capacity, together with its successors and assigns in such capacity, “Agent”) in favor of ECO-PAN, INC., a Colorado corporation (“Grantor”). All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.

WITNESSETH

WHEREAS, BB Merger Sub, Inc., a Colorado corporation as issuer, the guarantors party thereto, Wilmington Trust, as Trustee, and the Agent, entered into that certain Indenture dated as of August 18, 2014 (as amended, restated, supplemented, or otherwise modified from time to time, the “Indenture”) and Grantor and Agent entered into that certain Second Lien Security Agreement dated as of August 18, 2014 (the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Agent that certain Trademark Security Agreement dated as of August 18, 2014 (the “Trademark Security Agreement”) and recorded with the United States Patent and Trademark Office (“USPTO”) on August 20, 2014 at Reel/Frame No. 5348/0590, pursuant to which the Grantor unconditionally granted, assigned, and pledged to Agent, for the benefit of the Agent, the Trustee and the Noteholders, to secure the Secured Obligations, a continuing security interest (“Security Interest”) in all of its right, title and interest in and to the Trademark Collateral (as defined in the Trademark Security Agreement);


WHEREAS, the Grantor has requested that the Agent release its security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of the foregoing, the Agent hereby DISCHARGES, TERMINATES and RELEASES, without recourse, representation or warranty, its security interest in the Trademark Collateral, including the trademark registrations set forth in Schedule I, and agrees that all of the Security Interest in the Trademark Collateral is hereby discharged, terminated and released. The undersigned hereby transfers and assigns to the Grantor, without recourse, representation or warranty, any and all right, title and interest that the Agent may have obtained in and to the Trademark Collateral under the Security Agreement and the Trademark Security Agreement.
