RELEASE OF SECURITY INTEREST IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of September 8, 2017, by STELLUS CAPITAL INVESTMENT CORPORATION, in its capacity as agent for the Lender Group (the “Agent”), in favor of CALERO SOFTWARE, LLC, a Delaware limited liability company (as successor in interest to Veramark Technologies, Inc., a Delaware corporation, and Movero, Inc., a Delaware corporation) (the “Company”). Capitalized terms used and not defined herein have the meanings given to such terms in that certain Guaranty and Security Agreement or Trademark Security Agreement referenced below.

Reference is made to that certain Payoff Letter dated as of September 7, 2017 among the Agent, Calero Holdings, Inc. and the Company (the “Payoff Letter”).

FOR GOOD AND VALUABLE CONSIDERATION, the receipt and adequacy of which are hereby acknowledged, subject to the terms and conditions of the Payoff Letter, the Agent hereby terminates, discharges and releases the continuing security interest granted by the Company in favor of the Agent, for the benefit of the Lender Group, in the Trademark Collateral, including the trademarks listed on Schedule A attached hereto, pursuant to that certain Guaranty and Security Agreement, dated as of December 5, 2013, by and among the Company, the other grantors party thereto and the Agent, and that certain Trademark Security Agreement, dated as of December 5, 2013, executed by the Company in favor of the Agent and recorded with the United States Patent and Trademark Office on December 11, 2013 at Reel/Frame 5171/0446.

The Agent hereby consents to the recording of this Release with the United States Patent and Trademark Office.
