RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 7th day of September, 2017, by ESCALATE CAPITAL PARTNERS SBIC I, L.P. (together with its successors and assigns, "**Lender**").

Further, Lender understands and agrees that this Release may be recorded by or for Grantor with the United States Patent and Trademark Office and any other similar office or agency throughout the world. Lender also agrees to execute any other documents and take any further action reasonably necessary in any jurisdiction that Grantor may reasonably require to affect the intent and purpose of this Release.
