Assignor, on behalf of itself, its successors, assigns and legal representatives, hereby authorizes the U.S. Patent and Trademark Office and any official of any country or countries foreign to the United States whose duty it is to receive or register trademarks or applications therefor, to record Assignee, its successor or assign as the owner of the Assigned Marks, and to issue all registrations for the foregoing, to be in the name of Assignee, for the sole use of Assignee, its

successors, legal representatives, and assigns, in accordance with the terms of this Assignment. Assignor, on behalf of itself, its successors, assigns and legal representatives, and Assignee shall each promptly take, and shall cause their respective Affiliates (as defined in the Purchase Agreement) to take, any and all additional actions as may be necessary or appropriate to effect the assignment transactions contemplated, including but not limited to execution and delivery of individual assignment documentation for filing with the authorities of each individual country.
