RELEASE OF SECURITY INTEREST IN TRADEMARKS

WHEREAS, Grantors and Administrative Agent are parties to (i) Amended and Restated Patent and Trademark Agreement Security Agreement, dated as of November 30, 2009, (ii) Second Amended and Restated Patent and Trademark Security Agreement, dated as of July 1, 2014, and (iii) Reaffirmation of and First Amendment to Second Amended and Restated Patent and Trademark Security Agreement dated August 6, 2015 (collectively, the “Security Agreements”), in which the Grantors granted to the Administrative a security interest in the Company’s trademarks and trademark licenses, including, without limitation, the trademarks identified on Schedule A attached hereto;




