ASSIGNMENT

THIS ASSIGNMENT is made as of the 5th day of September, 2017 between Major League Softball, Inc., a California corporation with offices at 621 East Walnut Avenue, Burbank, CA 91501 ("Assignor") and Major League Baseball Properties, Inc., a New York corporation with offices at 245 Park Avenue, New York, NY 10167 ("Assignee").

WHEREAS, Assignor has used names and marks that comprise or contain the words MAJOR LEAGUE SOFTBALL, the letters MLS and/or a silhouetted batter design ("Applicant's MLS Marks"); and

WHEREAS, Assignor has filed a use-based application to register the standard character word mark MAJOR LEAGUE SOFTBALL ("Assignor's Word Mark"), Application Serial Number 77/372,368, for "Entertainment services, namely, organizing softball leagues for others; providing information relating to the organizing of softball leagues for others" in International Class 41 (the "'368 Application"); and

WHEREAS, Assignor has filed a use-based application to register the mark MLS MAJOR LEAGUE SOFTBALL and Design ("Assignor's Word and Design Mark"; together with Assignor's Word Mark and Applicant's MLS Marks, "Applicant's Marks")



as shown here: MAJOR LEAGUE SOFTBALL, Application Serial Number 77/372,446, for "Entertainment and information services related to organizing softball leagues for others" in International Class 41 (the "'446 Application"; together with the '368 Application, the "Applications"); and

WHEREAS, Assignee wishes to acquire all of Assignor's right, title and interest, including common law rights, in and to Applicant's Marks, including the Applications and the goodwill of the business symbolized thereby;

NOW, THEREFORE, for the sum of \$1.00 and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee, its successors and assigns, absolutely and forever, all of its right, title and interest in and to Applicant's Marks and the Applications, whether statutory or at common law, together with the goodwill of the business symbolized thereby, including but not limited to, all causes of action for any and all previously occurring infringements of the rights being assigned and the right to receive and retain the proceeds relating to those infringements.
