

### CONFIRMATORY TRADE MARK ASSIGNMENT ("CONFIRMATORY ASSIGNMENT")

### PARTIES:

- (1) **BELRON HUNGARY KFT.**, a company incorporated under the laws of Hungary, acting through its branch in the canton of Zug, Switzerland ("**ASSIGNOR**"), whose principal place of business is at Gotthardstrasse 20, CH-6300 Zug, Switzerland; and
- (2) **BELRON INTERNATIONAL LIMITED**, a company incorporated under the laws of England and Wales (company number: 02442568), whose registered office is at Milton Park, Stroude Road, Egham, Surrey TW20 9EL, United Kingdom ("ASSIGNEE").

### **BACKGROUND:**

- A. The ASSIGNOR is the applicant for, or proprietor of (as the case may be), the trade mark applications and registered trade marks set out in the Schedule.
- B. The ASSIGNEE is entitled to all rights in the TRADE MARKS (as defined below) including the right to sue in respect of every act of infringement thereof by virtue of an assignment with an effective date of 1 September 2017 (the "ASSIGNMENT").

in each case, whether registered or unregistered and including applications for registration of any such thing and rights of conversion (or similar rights triggered by the withdrawal of the UK from the European Union) of any such application for registration into a corresponding application with any national intellectual property, of which the ASSIGNOR is the proprietor ((i), (ii) and (iii) together defined as the "TRADE MARKS");

- (b) the absolute entitlement to any registered trade marks granted pursuant to any of the applications comprised in the TRADE MARKS, for the full term of such trade marks;
- (c) any common law rights and all the goodwill attaching to the TRADE MARKS; and
- (d) the right to sue in respect of every act of infringement of the TRADE MARKS, whether occurring before or after the ASSIGNMENT.


