TRADEMARK ASSIGNMENT

This Assignment is entered into as of August 1, 2017, between Emmis Radio, LLC, an Indiana limited liability company ("Assignor") and KWHY-22 Broadcasting, LLC, a California limited liability company ("Assignee").

WHEREAS, Assignor wishes to transfer the Registered Marks and any rights with respect thereto pursuant to the terms of the Purchase Agreement;

NOW, THEREFORE, the parties agree as follows:


1. Assignment. In accordance with the terms of the Purchase Agreement, Assignor does hereby irrevocably assign to Assignee the Registered Marks and any rights with respect thereto, including the goodwill of the business of the Station represented thereby.

As set forth in the Purchase Agreement, Assignor makes no representation or warranty with respect to the Registered Marks, except that no infringement claim is pending against Assignor, or to Assignor's knowledge threatened, with respect to use of the Registered Marks by the Station. Such marks or similar marks may be used by other stations (which may include stations owned by Assignor its affiliates). Each party is responsible for its own use thereof, if any.


