PARTIAL TERMINATION AND RELEASE OF LIEN IN INTELLECTUAL PROPERTY

THIS PARTIAL TERMINATION AND RELEASE OF LIEN IN INTELLECTUAL PROPERTY (this "Termination"), is dated as of September 6, 2017, and made by **PNC BANK, NATIONAL ASSOCIATION** ("PNC") in its capacity as Agent and as Lender under the below-defined Security Agreement, having an office at 500 First Avenue, Commercial Loan Service Center/DCC, Pittsburgh, Pennsylvania 15219 and **HSBC BANK USA, N.A.**, as Lender to CROCS, INC., a Delaware corporation, CROCS RETAIL, INC., a Colorado corporation, CROCS ONLINE, INC., a Colorado corporation, OCEAN MINDED, INC., a Colorado corporation, JIBBITZ, LLC, a Colorado corporation and BITE, INC., a Colorado corporation (collectively, "Grantors").

WHEREAS, pursuant to that certain Trademark and Patent Security Agreement dated as of September 25, 2009, made by Grantors in favor of PNC, as Agent for the Lenders (the "Security Agreement"), a security interest was granted by Grantors to PNC, as Agent in certain collateral, including the Specified IP Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 24, 2009, at Reel 4101 and Frame 0691;

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on November 23, 2009, at Reel 23556 and Frame 0447; and

WHEREAS, Agent and Lenders now desire to terminate and release their security interest in the Specified IP Collateral defined below;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent and Lenders hereby state as follows:


1. Definitions. The term "Specified IP Collateral," as used herein, shall mean and include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks and the patents listed on Schedule A hereto.

2. Release of Security Interest. Agent and Lenders hereby terminate, release and discharge their security interest in the Specified IP Collateral and reassign to the person or persons legally entitled thereto all of their right, title and interest in the Specified IP Collateral. Agent and Lenders acknowledge that this Termination may be filed along with any other necessary documentation with the United States Patent and Trademark Office or any other governmental office to evidence the partial termination and release granted by the Termination. Agent and Lenders will execute any additional documents necessary to confirm and effect this Termination.
