INTELLECTUAL PROPERTY SECURITY RELEASE

This Intellectual Property Security Release ("**Release**") dated as of August 28, 2017 ("**Effective Date**") is given by Silicon Valley Bank, with an address of 3003 Tasman Drive, HG-150, Santa Clara, California 95054 (the "**Agent**") to Resolver Inc. (*f/k/a BPS Resolver Inc.*), with an address of 257 Adelaide Street West, Suite 400, Toronto, Ontario M5H 1X9 ("**Borrower**").

WHEREAS, the Agent and the Borrower are, *inter alios*, parties to that certain credit agreement dated as of November 14, 2014 ("**Credit Agreement**"), and Borrower was indebted to the Agent pursuant to such Credit Agreement;

WHEREAS, to secure such indebtedness, Borrower and Agent entered into certain security agreements ("**Security Agreements**") by which the Borrower granted to the Agent a security interest in and to, among other things, all present and future intellectual property rights in which the Borrower has any right, title or interest, including, without limitation, the properties identified on Schedule A ("**Intellectual Property Collateral**");

WHEREAS, Agent recorded the Security Agreements with the United States Patent and Trademark Office under Reel/Frame No.: 005410/0001; and

WHEREAS, Borrower has paid said indebtedness in full and said security interest is thereby not required.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent does hereby release, discharge and relinquish to Borrower its entire right, title and interest in, to and under the Intellectual Property Collateral, including, without limitation, its security interest and lien on the Intellectual Property Collateral, together with the goodwill of the business symbolized by the trademarks and trademark registrations included in the Intellectual Property Collateral, and Agent hereby transfers to Borrower, without recourse, all of its right, title and interest in and to the Intellectual Property Collateral. Agent does hereby agree that the filing of said Security Agreements may be

removed of record in entirety by the filing of this Release with the United States Patent and Trademark Office, and wherever else such filing may be needed.

This Release shall be binding upon and inure to the benefit of the Borrower, the Agent, and their respective successors and assigns.
