TRADEMARK SECURITY AGREEMENT

This **TRADEMARK SECURITY AGREEMENT** (this "Agreement"), dated as of September 14, 2017, is made by **RISING TIDE PARENT INC.**, a Delaware corporation ("Parent"), **RISING TIDE MERGER SUB INC.**, a Delaware corporation, as initial borrower ("Merger Sub"), **WEST MARINE, INC.**, a Delaware corporation ("West Marine"), **WEST MARINE PRODUCTS, INC.**, a California corporation ("WMPI"), **W MARINE MANAGEMENT COMPANY, INC.**, a California corporation ("WMCI"), and **WEST MARINE PUERTO RICO, INC.**, a California corporation ("WMPR" and together with Parent, Merger Sub, West Marine, WMPI, and WMCI, collectively, the "Grantors" and each individually, a "Grantor") in favor of **BANK OF AMERICA, N.A.**, as agent for the equal and ratable benefit of the Secured Parties (as defined in the Loan Agreement) (in such capacity, together with its successors and assigns in such capacity, the "Agent").

Reference is hereby made to that certain Loan and Security Agreement dated as of September 14, 2017 (as amended, amended and restated, restated, supplemented, modified or otherwise in effect from time to time, the "Loan Agreement"), by and among the Grantors, each other Person from time to time party thereto as a Borrower or Guarantor, the financial institutions from time to time party thereto (collectively, the "Lenders"), and Agent. Each Grantor has pledged and granted to Agent a continuing security interest in all intellectual property, including the Trademarks (as defined below).

NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, each Grantor agrees, for the benefit of Agent, as follows:

1. Definitions. Unless otherwise defined herein or the context otherwise requires, terms used in this Agreement have the meanings provided or provided by reference in the Loan Agreement.

2. Grant of Security Interest.

(a) This Agreement is made to secure the performance and payment of all of the Obligations. Upon the Full Payment of the Obligations, Agent shall promptly, upon such satisfaction, execute, acknowledge, and deliver to each Grantor all reasonably requested instruments in writing releasing the security interest in the Trademarks acquired under this confirmatory grant.

(b) Each Grantor hereby pledges and grants to Agent, for the benefit of the Secured Parties, a continuing security interest in and Lien upon all of the below listed Property of such Grantor, whether now owned or hereafter acquired, and wherever located: (i) its trademarks (including service marks), trade names, trade dress and the registrations and applications for registration thereof, including the foregoing listed on Schedule A, (provided that no security interest shall be granted in any intent-to-use trademark application prior to the filing and acceptance of a "Statement of Use" or "Amendment to Allege Use" with respect thereto) and the goodwill of the business symbolized by the foregoing; (ii) all renewals of the foregoing; (iii) all income, royalties, damages, and payments now or hereafter due or payable with respect thereto, including, without limitation, damages, claims, and payments for past and future

infringements thereof; (iv) all rights to sue for past, present, and future infringements of the foregoing, including the right to settle suits involving claims and demands for royalties owing; and (v) all rights corresponding to any of the foregoing throughout the world (the "Trademarks").

3. Purpose. This Agreement has been executed and delivered by each Grantor for the purpose of recording the grant of security interest herein with the United States Patent and Trademark Office. The security interest granted hereby has been granted to Agent in connection with the Loan Agreement and is expressly subject to the terms and conditions thereof. The Loan Agreement (and all rights and remedies of Agent thereunder) shall remain in full force and effect in accordance with its terms.

4. Acknowledgment. Each Grantor does hereby further acknowledge and affirm that the rights and remedies of Agent with respect to the security interest in the Collateral granted hereby are more fully set forth in the Loan Agreement, the terms and provisions of which (including the remedies provided for therein) are incorporated by reference herein as if fully set forth herein. In the event of any conflict between the terms of this Agreement and the terms of the Loan Agreement, the terms of the Loan Agreement shall govern.

5. Counterparts. This Agreement may be executed in counterparts, each of which shall be deemed an original, but all of which together constitute one and the same original.

6. Governing Law. This Agreement and all claims shall be governed by the laws of the State of New York, without giving effect to any conflict of law principles except federal laws relating to national banks.


7. Intercreditor Agreement. Notwithstanding anything herein to the contrary, the Agent and each Grantor acknowledge that the Lien and security interest granted to the Agent, for the benefit of the Secured Parties, pursuant to this Agreement and the exercise of any right or remedy by the Agent under this Agreement are subject to the provisions of the Intercreditor Agreement. In the event of any conflict between the terms of the Intercreditor Agreement and this Agreement, the terms of the Intercreditor Agreement shall govern and control.
