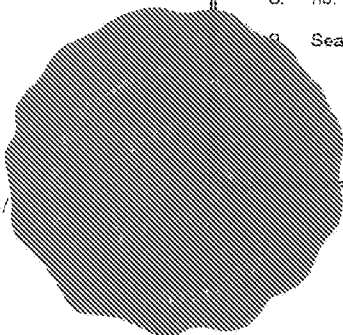

**ASSIGNMENT AGREEMENT**

Between

PERFETTI VAN MELLE Benelux B.V. of Zoete Inval 20, 4815 HK Breda, The Netherlands - hereinafter to be referred to as PVM;

and

Frisk International N.V. of Technologielaan 2, 3001 Leuven, Belgium hereinafter to be referred to as FRISK;

Hereinafter also together referred to as the "Parties" or individually as "Party".

- a) PVM sells confectionery products produced by itself or by factories owned by Perfetti Van Melle Group; to whom PVM also belongs;
- b) Frisk sells confectionery products packed by itself and produced by factories owned by Perfetti Van Melle Group; to whom Frisk also belongs;
- c) Frisk has decided to assign its trademarks to PVM that accepts the assignment

IT IS AGREED AS FOLLOWS:

**Article 1 Object of the Agreement**
