**ASSIGNMENT**

**ASSIGNMENT.** Assignor hereby transfers and assigns to Assignee, without any restrictions, reservations, or limitations, the entire and exclusive right, title, and interest in and to the Marks, including, without limitation, the Applications, together with all of the goodwill associated with and symbolized by the Marks, and Assignee accepts all of the foregoing from Assignor.

**REPRESENTATIONS AND WARRANTIES.** Assignor represents and warrants that it is authorized to make this assignment and to grant the rights herein.

**RECORDATION OF AGREEMENT.** This Agreement may be recorded with the United States Patent and Trademark Office to document and effectuate the assignment of the Marks and Applications from Assignor to Assignee.
