NUNC PRO TUNC TRADEMARK ASSIGNMENT

WHEREAS, The Vantone Group, LLC, a New York limited liability company with an office located at 857 Ninth Ave #2B New York, New York 10019 (hereinafter referred to as "Assignor") was the sole and exclusive owner of the trademarks ("Marks") as shown on the attached Schedule of Trademarks, incorporated by reference herein; and, and the business and goodwill thereto pertaining; and

WHEREAS, Assignor was involved a lawsuit in the United States District Court for the Southern District of New York (13CV7639-LTS-FM) to enforce the Assignor's rights to these Marks.

WHEREAS, on June 30, 2017, respective counsels for Assignor and Vantone US, Inc., a Delaware corporation with an office located at 7 World Trade Center, 33rd Floor 250 Greenwich St., New York, New York 10007 (hereinafter referred to as "Assignor") and the other related parties to the lawsuit concluded a mediation presided over by the Honorable Judge James. L. Cott, United States Federal Court Magistrate and agreed to the resolution as set forth in a Confidential Settlement Agreement and Mutual Release.

WHEREAS, as part of that Agreement, Assignor was required to assign its rights to the Marks to Assignee and to request the New York Department of State to dissolve Assignor's status as a limited liability company.

WHEREAS, on July 21, 2017, prior to assigning its rights to the Marks to Assignee, Assignor requested the New York Department of State to dissolve Assignor's status as a limited liability company.

WHEREAS, through inadvertence no assignment of said Marks, the goodwill thereto pertaining, was executed in a form recordable in the United States Patent and Trademark Office prior to the dissolution of Assignor's status as a limited liability company.

NOW, THEREFORE, the Member Manager of Assignor, for good and valuable consideration, receipt of which was acknowledged, and in conformity with his intent and the actual operation of his businesses, does hereby, *nunc pro tunc* July 20, 2017, sell, assign, set over and transfer to Assignee, all right, title and interest in and to said Marks, the goodwill thereto pertaining, the same and the rights of Assignor to be held and enjoyed by Assignee for its own use and enjoyment, and for the use and enjoyment of its

successors, assigns or other legal representatives, as fully and entirely as the same would have been held and enjoyed by said Assignor if this assignment had not been made.

IN TESTIMONY WHEREOF, said Assignor has executed this instrument on the 8 day of September, 2017.
