THIS ASSIGNMENT OF TRADE MARKS is made on

22 June

2017

BETWEEN:

- (1) **THEO FENNELL LIMITED** (in administration) (company number 01955534) whose registered office is at 2b Pond Place, London SW3 6TF ("Company");
- (2) **WILLIAM MATTHEW HUMPHRIES TAIT** and **COLIN MICHAEL TREVETHYN HAIG** both of BDO LLP, 55 Baker Street, London W1U 7EU ("Administrators"); and
- (4) **ENDLESS NEWCO 7 LIMITED** (registered number 10673560) whose registered office is at 3 Whitehall Quay, Leeds, England, LS1 4BF ("Purchaser").

BACKGROUND:

- A The Company is the owner of the registered trademarks set out in the attached schedule ("Trade Marks").
- B The Administrators were appointed joint administrators of the Company on 18 May 2017 by the directors of the Company pursuant to paragraph 22 of schedule B1 to the Insolvency Act 1986.
- C The Company has agreed to sell the business and assets as a going concern of the Company by an agreement dated on or around the date hereof agreed which includes the Trade Marks ("Sale Agreement") and this deed is to give effect to the Sale Agreement by assigning the Trade Marks to the Purchaser on the terms and conditions set out below.

THIS DEED WITNESSES as follows:

1. ASSIGNMENT

In consideration of the sums set out in the Sale Agreement the Company assigns and transfers to the Purchaser all such right, title and interest as it may have in and to the Trade Marks, including all statutory and common law rights attaching to the Trade Mark and the goodwill attaching to the Trade Marks.

2. PAST INFRINGEMENTS

The Company confirms that the Purchaser shall be entitled to sue for past infringements of the rights assigned in clause 1 above and to retain any damages obtained as a result of such action.

3. FURTHER ASSURANCE

The Company undertakes at the request and expense of the Purchaser for such time as the Administrators remain in office to do all acts and execute all documents that may reasonably be required from time to time by the Purchaser to vest in the Purchaser the title of the Purchaser to the Trade Marks assigned in clause 1 above, whether in connection with any registration of such title or to protect the Purchaser's rights in the Trade Marks or otherwise in accordance with the terms of this deed. The terms of all such documents shall be subject to the prior approval of the Administrators' Solicitors (as defined in the Sale Agreement).

4. EXCLUSION OF COVENANTS

No covenant for title or title guarantee of any sort shall be implied into this deed and the exclusions and limitations set out in the Sale Agreement shall apply to this deed as if set out in full in this deed.

5. EXCLUSION OF ADMINISTRATORS' PERSONAL LIABILITY

- 5.1 The Administrators have entered into and signed this agreement as agents for or on behalf of the Company and neither they, their firm, partners, employees, advisers, representatives or agents shall incur any personal liability in respect of any of the obligations undertaken by the Company or in respect of any failure on the part of the Company to observe, perform or comply with any such obligations or under or in relation to any associated arrangements or negotiations or under any document or assurance made pursuant to this agreement or any collateral agreement which may exist or be implied in any way in respect of the assigned assets or rights. The Administrators are party to this agreement in their personal capacities only for the purpose of receiving the benefit of the exclusions, limitations, undertakings, covenants and indemnities in their favour contained in this agreement.
- 5.2 The Purchaser acknowledges that the statutory charges in paragraph 99 of Schedule B1 of the Insolvency Act 1986 shall not apply to any breach by the Company of any of its obligations under this agreement.
- 5.3 This deed is intended to take effect as a deed notwithstanding that it has been signed by the Administrators under hand only.

6. TAXATION

- 6.1 The consideration payable under clause 1, for VAT purposes made or deemed to be made under or in connection with this agreement shall be deemed to be exclusive of VAT. The Purchaser shall (in addition to the consideration) pay to the Company all VAT chargeable in relation to the assignment subject to and in accordance with the Sale Agreement.
- 6.2 The Purchaser shall be solely responsible for all taxes (other than any corporation tax payable by the Company) stamp duty or equivalent imposts levied in connection with the sale and/or transfer of the assignment.

7. THIRD PARTIES

A person who is not party to this deed shall have no right under the Contracts (Rights of Third Parties) Act 1999 to enforce any term of this deed. This clause does not affect any right or remedy of any person which exists or is available otherwise than pursuant to that Act.

8. COUNTERPARTS

This agreement may be executed in any number of counterparts, and by the parties on separate counterparts, but shall not be effective until each party has executed at least one counterpart. Each counterpart shall constitute an original of this agreement, but all the counterparts shall together constitute one and the same agreement.

9. GOVERNING LAW AND JURISDICTION

This agreement and any dispute or claim arising from or in connection with this agreement ("Dispute") is governed by and shall be construed in accordance with English law. Each party irrevocably agrees that the courts of England shall have exclusive jurisdiction to settle any Dispute.






