**FIRST:** The name of the Maryland corporation is InfoZen, Inc. (the "Corporation") and the date of filing of its original articles of incorporation with the State of Maryland Department of Assessments and Taxation is August 31, 1995.

**FIFTH:** The Effective Time (the "Effective Time") of the Articles of Conversion of the Corporation shall be upon the acceptance for record by the State of Maryland Department of Assessments and Taxation.

**SIXTH:** In accordance with the provisions of Title 3, Subtitle 9, § 1-301 of the Maryland Corporations and Associations Code Annotated, the undersigned Raj Ananthanpillai certifies under the penalties of perjury that to the best of his knowledge, information and belief, the matters and facts set forth in these Articles of Conversion with respect to the approval thereof are true in all material respects.
